

## **Wasatch Freestyle Foundation Devo Competition Saturday January 21, 2012**

Please join The Wasatch Freestyle Foundation for the first Intermountain Division Devo competition of the 2011-2012 ski season at the Utah Olympic Park on Saturday January 21<sup>st</sup> 2011. Devo events are designed for athletes 7-12 yrs and 13-14 yrs new to the sport.

### **Schedule:**

5:30-8:30 p.m.: in person registration at UOP Day Lodge

6:00-8:00 p.m.: optional on-course practice for athletes

#### **Saturday, January 21, 2012**

8:00-9:00 a.m.: in person registration at UOP Day Lodge

10:00-11:00 a.m.: warm-up and course familiarization

11:05: begin event

### **Registration:**

- Entry fees are \$35 per competitor. This does not include UOP day pass (wrist band) required to access the venue.

- Register in person at Olympic Park Day Lodge, as scheduled above.

### **All athletes must have ALL of the following**

1. Completed Event Registration form, AND,
2. Signed Wasatch Freestyle Liability Release Form, AND
3. Signed UOP release waiver –all minors require parent/guardian signature, AND
4. Valid UOP Wrist Band. Issued daily by UOP at museum desk for \$12 per day (or obtain a wrist band using your UOP season pass.)

**Lift Tickets (UOP Facility Pass/Wrist Bands):** Lift tickets are available at the UOP museum desk .

**Bibs:** All competitors must wear a competition bib during official training, competition and the award ceremonies. Athletes may use their USAA bib, and bibs will be distributed at Registration on January 20<sup>th</sup> and January 21<sup>st</sup> for those who need them. ALL BIBS MUST BE RETURNED at the end of the competition Saturday.

**Liability:** All athletes, officials, staff, spectators and family members who attend or participate in this event do so at their own risk. Neither the Utah Olympic Park, the Wasatch Freestyle Foundation, Inc., nor its employees, officers, directors or staff, shall be responsible for any injuries, death, damages to property or loss caused by or occurring during the event

**Medical Insurance:** Every competitor must have his/her own medical insurance.

**Awards:** Awards will be held at the finish area immediately following the competition Saturday January 21<sup>st</sup> 2012. Awards will be given to the top 3 skiers in each age and gender group.

**Spectators:** Spectators are encouraged, and spectators can view the event without having to purchase a facility pass. No skier is allowed on the hill who is not supervised by a team coach. The UOP runs a food concession stand at the rear of the museum building.

# ACKNOWLEDGMENT OF RISK, CONSENT TO MEDICAL TREATMENT AND MEDIA CONSENT AGREEMENT

**THIS IS A LEGALLY BINDING AGREEMENT! PLEASE READ CAREFULLY BEFORE SIGNING!**

For and in consideration of my minor child being allowed to use the Utah Olympic Park (“UOP”) and/or any part of its facilities, I acknowledge and understand that my minor child could sustain serious injuries, including, but not limited to, paralysis, head/brain injuries, and even **DEATH** as a result of using any of the facilities at the Utah Olympic Park or participating in any of the sporting events available at the Utah Olympic Park. I further acknowledge and understand that obeying and following safety rules and/or instruction does not guarantee my child’s safety and that there are many serious risks involved in using these facilities. **The UOP is NOT in any manner an insurer of my child’s safety.**

I also understand that the equipment and facilities at the UOP are being offered to my child “**AS IS**” and “**WITH ALL FAULTS**”. **NO implied warranty of merchantability or fitness** or any other warranty of any kind is being offered to my child/children or to me on behalf of my child with respect to the equipment or facilities used by my child.

I hereby consent to allow the UOP to administer (directly or indirectly) first aid and other emergency medical treatment to my minor child for any injury or illness that occurs during my minor child’s use of UOP’s facilities or participation in the sporting events. I have/my minor child has adequate health insurance or resources to cover the costs of treatment in case of any such injury or illness.

I also grant to the Olyparks and its assigns the right to use, reproduce, display, distribute and make derivative works, in any and all media, of my minor child’s voice, image and/or likeness recorded while using the UOP’s facilities or participating in the sporting events and any biographical information furnished by me/my minor child to the UOP.

I have read and understand this Agreement and voluntarily enter into it without any reservation whatsoever. I further agree that no representations have been made to me other than those expressly contained herein and that I have the express permission of my spouse and any other guardian/parent of my minor child to enter into this Agreement on behalf of my minor child. In the event any part of this Agreement is deemed unenforceable, the other portions will remain enforceable. Any lawsuit concerning this Agreement shall be filed in the Third Judicial State District Court in and for Summit County, State of Utah.

## WASATCH FREESTYLE LIABILITY RELEASE FORM (January 21, 2012 Devo Competition)

RELEASE OF LIABILITY: I, the undersigned, and if I am a person under 18 years of age, my parents and I, am/are aware that the sport of skiing, and even more so, freestyle skiing, in its various forms, is a hazardous sport involving the risk of injuries and death. The risks include inherent risks and risks associated with the operation of the ski area. Examples of risks of skiing include, but are not limited to, terrain changes; lift towers; signs; trees; stumps; avalanche; ice; snow conditions; collisions with other skiers, man-made objects or operating equipment; failure to ski within one's ability or under control; failure to negotiate mountain terrain grooming equipment; failure of chairlift equipment; and failure or inappropriate adjustment of my ski equipment. I realize that injuries are a common and ordinary occurrence of this sport. I agree, as partial consideration for my participation in this competition to assume and accept all such risks or personal injury, death or property damage which arise from the sport, program, activity and/or actions, omissions or negligence of Wasatch Freestyle and/or Venues, their employees, volunteers and agents in the course of this event and it's ancillary activities. I, my heirs, guardians, legal representatives, or assigns agree to release from any legal liability and promise never to file a claim or suit against Wasatch Freestyle Foundation, Inc., Friends of Wasatch Freestyle, Inc., or the owner or operator of any venue where we conduct team activities and events ("Venues") for any injuries or death caused by or resulting from the risks which I have accepted and assumed herein or in any other way related to my participation in skiing, the operation of the ski area, or ski programming and events, regardless of whether or not Wasatch Freestyle Foundation, Inc., Friends of Wasatch Freestyles, Inc., Venues, their agents, volunteers or employees were negligent or whether or not the injury resulted from an inherent risk of skiing. Venues, include, but are not limited to, Deer Valley Resort, Deer Valley Corporation, Snowbird Ski and Summer Resort, Snowbird Corporation, the Utah Olympic Park, and the owner of any property or facility at Deer Valley or Snowbird, their officers, members affiliated organizations, agents, volunteers or employees

INDEMNITY: I, the undersigned, and if I am a person under 18 years of age, my parents and I, have read and understood the terms of this Registration and Release Agreement, which is an essential part of conditions under which Wasatch Freestyle will offer its programs and events. I hereby agree to indemnify and hold harmless Wasatch Freestyle Foundation, Inc., Friends of Wasatch Freestyle, Inc., and Venues, agents, volunteers and employees from any claims arising from my participation in Wasatch Freestyle programming and/or competitions, and any claims brought against Wasatch Freestyle, Friends of Wasatch Freestyle, and/or Venues arising from my actions. I am signing this document freely and of my own accord, realizing it is binding upon myself, my heirs and assigns, and in the event that I am signing it on behalf of any minors, that I have full authority to do so, realizing its binding effect on them as well as myself.

MEDIA RELEASE: I hereby authorize and give my full consent to Wasatch Freestyle to use any and all photographs, videotapes and/or film in which I appear while training for or competing in the activity with which I am affiliated with Wasatch Freestyle. I further agree that

Wasatch Freestyle may transfer, use or cause to be used these photographs, videotapes, or films for any exhibitions, public displays, commercials, art and advertising purposes, and television programs without limitations, reservations or compensation to me.

**CHOICE OF LAW AND VENUE.** This Agreement, the legal relationship between the Skier and Wasatch Freestyle and/or Venues, and duties that arise from the legal relationship between the Skier and Wasatch Freestyle, Friends of Wasatch Freestyle and/or Venues, shall be governed by and construed under the law of the State of Utah. Any action to enforce this agreement, or any legal action between or among the Skier and Wasatch Freestyle, Friends of Wasatch Freestyle and/or Venues shall be filed in a court of competent jurisdiction in Summit County, Utah.

**EFFECTIVE DATES OF AGREEMENT.** This Agreement is supplemental to any prior registration and release agreement(s) made between me and Wasatch Freestyle Foundation, Inc. It shall survive and govern, without limitation, my participation in any Wasatch Freestyle program or activity, regardless of season or year, until superceded or supplemented by another signed, written registration and release agreement. Where this Agreement conflicts with the terms of any prior release or indemnity agreement I have signed for the benefit of Wasatch Freestyle Foundation, the terms most beneficial to Wasatch Freestyle Foundation shall govern.

**CONCUSSION AND HEAD INJURY POLICY.** (UCA §26-53-201.) Any athlete under the age of 18 years suspected of having a concussion/traumatic brain injury must be removed immediately from participation in a team activity. The minor athlete will be prohibited from further participation until evaluated and cleared in writing to resume participation in team activities by a qualified health care provider trained in the evaluation and management of concussive head injuries within three years of the day on which the written statement is made. A repeat concussion that occurs before the brain recovers from the first -- usually within a short period of time (hours, days, or weeks) -- can slow recovery or increase the likelihood of having long-term problems. In rare cases, repeat concussions can result in edema (brain swelling), permanent brain damage, and even death. Please refer to the Center for Disease Control for additional resources on the subject.
